**Tuition Payable as follows:**

1. Non-Refundable/Non-Transferable Registration fee of \$500 is due upon registration for *all* students.
2. May 2027 tuition will be billed July 1<sup>st</sup> 2026 and serves as the tuition deposit and last tuition installment for the 2026-2027 year.
3. The balance of the yearly tuition will be billed in 9 monthly installments, due monthly from August 2026 through April 2027.
4. Tuition is due on the 1<sup>st</sup> of each month, and will be subject to a \$50.00 fee if not received by the 10<sup>th</sup>.
5. An option to pay one full-year tuition is available at a 3% discount. Cash or check only. (August 1<sup>st</sup> 2026 deadline)
6. An option to pay two years' tuition is available at a 7% discount. Cash or check only. (August 1<sup>st</sup> 2026 deadline)
7. Refunds can only be made if you move from Sonoma County.
8. Sibling Discount: 10% for 2<sup>nd</sup> child, 15% for 3<sup>rd</sup> child.
9. Any modification of these terms must be in writing, signed by both parties.
10. Sibling discount does not apply to before and after school care.

Tuition is paid in one payment, due upon enrollment, or ten monthly installments. The final installment (MAY 2027) is due JULY 1, 2026. The remaining nine installments are due on the first day of every month from AUGUST through APRIL. Tuition portion will be prorated if the student begins attending after the first day of school. The materials and registration fee will not be prorated.

\_\_\_\_\_ I agree that tuition is due the 1<sup>st</sup> of each month, August 1<sup>st</sup> 2026 through April 1<sup>st</sup> 2027 (with May 2027 installment due upon enrollment). A late fee of \$50 is charged if tuition is not paid by the 10<sup>th</sup> of each month.

\_\_\_\_\_ I agree that Watershed accepts payments with cash, checks, and electronic funds transfers (EFT).

\_\_\_\_\_ I agree WMS closes at 5:30pm, and WMS will charge \$5 for every minute of care after 5:30 pm.

\_\_\_\_\_ I agree that WMS is unable to give "make up" days or give credit for absences.

\_\_\_\_\_ I agree that if needed, one week of unscheduled school closures will be made up during flex week at the end of the academic year.

\_\_\_\_\_ I agree that WMS may need to close for the health and safety of the students and staff and that it is possible that not all closures will be able to be made up.

\_\_\_\_\_ I agree that I will inform WMS immediately of any change in contact information (phone number, address etc.).

\_\_\_\_\_ I understand that I may contact the licensing agency if fault is found in the operation of WMS facility or in the treatment of my child.

\_\_\_\_\_ I understand, per regulation 101200 that A. The department or licensing agency shall have the authority to inspect the licensed facility, and that the agency will have the authority to interview children or staff and to inspect and audit child or facility records without prior consent. Also, the licensing agency shall have the authority to observe the physical condition of the children, including conditions which could indicate abuse, neglect, or inappropriate placement and to have a licensed medical professional physically examine the child.

\_\_\_\_\_ I understand that WMS or myself may terminate Admission Agreement with thirty (30) days' notice without cause. Further, WMS may terminate enrollment for my child/children at any time for non-payment of tuition. WMS may also terminate this Agreement immediately if the actions of parent, guardian, or child pose a threat to the health and safety of others or the stability of the school environment. WMS will notify parent(s) of any rate change with thirty (30) days' notice.
